- INITIALS _____ 1. I have been provided with a copy of 40 Fathom Grotto's current policies and procedures. I have read these policies and procedures, and any questions I may have had regarding them have been explained to my satisfaction.
- INITIALS _____ 2. I understand and agree that 40 Fathom Grotto reserves the right to amend its policies and procedures at any time, for any reason, without notice, and that it is my responsibility to visit the *40FathomGrotto.com* website or otherwise contact 40 Fathom Grotto prior to bringing any group or individual, to learn about the latest changes to or updates in policies and procedures, so that my party and I can follow them.

- Remain in Active leadership-level status with at least one widely recognized diver-training organization and be able to provide proof of same.
 - Maintain current professional liability insurance for training and/or supervising divers, and be able to provide the Grotto with a current certificate of insurance that specifically names *Hal and Jan Watts* (lessor) and *Commercial Diving Academy of Jacksonville, Inc.* (lessee) as Additional Insureds.
 - Guide divers or teach at the Grotto, or assist in one of these activities, at least once every two years.
 - Sign a new *40 Fathom Grotto Guide Agreement* at the beginning of each calendar year.
- INITIALS _____ 5. I further understand and agree that 40 Fathom Grotto may, at any time, change the requirements for achieving or maintaining Guide status, and in such case, I may be required to meet additional requirements to maintain my Guide status, including the execution of a new and/or amended *40 Fathom Grotto Guide Agreement*.
- INITIALS _____ 6. Finally, I understand and agree that my status as a 40 Fathom Grotto Guide continues solely at the discretion of 40 Fathom Grotto, and that the operators of the Grotto may suspend or revoke my Guide status at any time, for any reason, without recourse or compensation.
